**Cost to Educate**

**Description of Fees**

The technology and book fee helps to pay for the expenses of maintaining the 1-to-1 Chromebook program, curricular expenses, and annual Yearbooks. The Activity Fee covers expenses for recess, recreation, and playground equipment as well as cultural enrichment programs.

Tuition is paid under terms of the payment plan submitted in TADS, the tuition management system.

**Policies and Procedures for Tuition Payment & Grants**

- I. **Tuition Policy:** To qualify for the Catholic tuition rate, a family must actively participate in a parish in the Archdiocese of Washington.
- II. **Tuition Payments:** Tuition payments are made annually, semi-annually, or monthly on the TADS tuition management system.
- III. **Registration:** A non-refundable payment of \$200 per family is due at the time of annual enrollment or first-time registration.
- IV. **Withdrawal from School:** Due to financial obligations and agreements with our teachers, the school must be notified during the annual registration period that a child will not return for the following school year. If the child is registered for the following year, the school may proceed by billing tuition on a 10-month payment plan if there has not been notice of withdrawal. If the child is not registered, the school cannot guarantee holding the child's place in the class for the following school year.
- V. **Consequences of Late/Non-Payment Policy:** Tuition payments are expected to be made according to the dates established in the tuition-payment plan. Families are urged to communicate to the principal and pastor if circumstances cause a delay. A fee will be charged on TADS for late payment. If there is an unpaid balance on a family's account, the school may inform a family of the date after which a child will not be permitted to attend school. The school reserves the right to cancel the registration of a student whose family fails to meet its tuition, After Care, or fees obligation. Student records will be held until accounts are balanced.
